# Public Law

---

Oliver acts for claimants and defendants in a wide variety of contexts. In the national security context, he has acted for the intelligence services, government, the police and oversight bodies in relation to: breach of confidence and injunction claims; closed material procedures and public interest immunity; contempt of court; extremism, including in education; investigatory powers and data protection; mediations; and reporting restrictions. Furthermore, he has also worked on more than 10 different claims for MOD under special forces confidentiality contracts.
